The Mooresville Town Council met in regular session on Tuesday, August 19, 2014 , at 6:30 P.M. at the Mooresville Government Center.

Town Council members present: President Mark Mathis, Vice-President Virginia Perry, Jeff Cook, Tony Langley, and George Watkins.

The prayer was given by Randy Weddle from the Community Church of Mooresville.

A motion was made by Councilman Watkins with a second by Councilwoman Perry to approve the minutes from August 5, 2012 meeting.

First on the agenda 911 County Dispatch: Arlie Kelly at 38 West South Street spoke before the council and talked about the flood of 2008. Most of Martinsville and Johnson County were under water and if there is a tornado the center will be lost. It makes sense to keep our center here in Mooresville. He said votes bring consequences and you have to decide.

Toby Dolen, a former councilman, spoke before the council and told them he wanted the dispatch in Mooresville kept open.

Council President Mathis told the audience the article in the paper about putting an agreement together was not correct. The countywide dispatch has not been voted on yet by the Mooresville Town Council. He said the first week dispatch was discussed, Councilwoman Perry gave a speech and she made a motion to vote the central dispatch is not good for Mooresville. Council President Mathis asked the council if they wanted to vote tonight or wait until the next meeting.

Councilman Cook gave a second to Councilwoman Perry's motion. The motion carried 3-2 to not join the county dispatch. Councilman Langley and Councilman Watkins opposed.

A motion was made by Councilman Watkins with a second by Councilwoman Perry to approve the Circle City quote. Motion carried 5-0. Council President said a non-profit organization may help with the cost. Not yet determined.

Legal: Town attorney Tim Currens: A motion was made by Councilman Watkins with a second by Councilman Langley to approve a bond ordinance for the Redevelopment Commission. Councilwoman Perry stated she wanted to have a discussion with Harold Gutzwiller, Chairman of the Redevelopment Commission. The Motion carried 5-0.


A motion was made to approve Ordinance #11, 2014, a flood ordinance, by Councilman Watkins with a second by Councilman Langley. Motion carried 5-0.

A motion was made by Councilman Langley with a second by Councilwoman Perry to approve payment of claims in the amount of \$384,726.74.


Motion carried 5-0
